

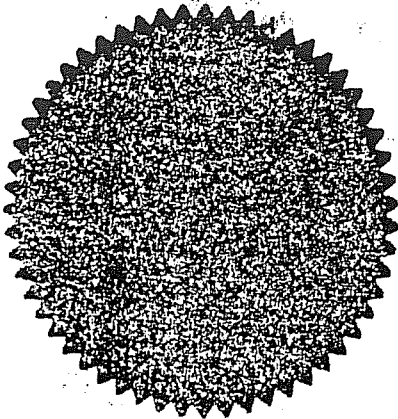

ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of the Alaska Nonprofit Corporations Act A.S. 10.20.005 et., seq., the undersigned Ron Rivard, Robert L. Russell and John Roberts, being born citizens of the United States of America and over the age of nineteen (19) years being desirous of forming a non-profit association for the purposes hereinafter specified and in conformity with the laws of the State of Alaska, do make and subscribe the following Articles of Incorporation in triplicate:

ARTICLE ONE

NAME

The name of the association shall be MEADOW RIDGE CONDOMINIUM ASSOCIATION, INC.

ARTICLE TWO

PURPOSE

This association is authorized to conduct any lawful activities as may be necessary to accomplish the objectives of MEADOW RIDGE CONDOMINIUM ASSOCIATION, INC., allowed by law.

ARTICLE THREE

PERIOD OF DURATION

The period of duration of this association shall be perpetual.

ARTICLE FOUR
