We, the undersigned natural persons of the age of nineteen (19) years or more, acting as incorporators for the purposes of creating a non-profit corporation under the laws of the State of Alaska, as contained in Title 10, Chapter 20, of the Alaska Statutes, entitled "Non-Profit Corporations," and the amendments thereto, do hereby set forth and adopt the following Articles of Incorporation for such corporation.

ARTICLE I

Name
