We, the undersigned, being natural persons over the age of mineteen (19) years, desiring to form a nonprofit corporation pursuant to the Alaska Business Corporation Act, do hereby certify as follows:

ARTICLE I

The name of this corporation ("Association" herein) is Great Place Condominium Association.

ARTICLE II

The purposes for which the corporation is formed are as follows:

- In the specific and primary purposes are to provide for maintenance, preservation and architectural control of a condominium project on real property located in the City of Anchorage, Alaska, known as Great Place, a Cendominium, and the structures and improvements thereon, and such other adjacent projects whose unit owners become members of the corporation under the terms of the Declaration recorded for the Great Place, a Condominium.
 - 2. The general purposes and powers are:
- (a) To promote the health, safety and welfare of the residents within said real property.
- (b) To exercise all of the powers and privaleges and to perform all of the duties and obligations of the Association arising from the Declaration of Covenants and restrictions and cond minium plan applicable to the property described above ("Declaration").
- (c) To fix, lovy, collect and enforce payment by lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association.

- (d) To have and to exercise any and all powers, rights and privileges which a corporation organized under the nonprofit corporation law of the State of Alaska by law may now or hereafter have or exercise.
- agant, joint venturer, partner or otherwise.

The foregoing statements of purposes shall be construed as a statement both of purposes and of powers, and purposes and powers in each clause shall not be limited of restricted by reference to or inference from the terms or provisions of any other clause, but shall be broadly construed as independent purposes and powers. Notwithstanding any of the above statements of purposes and powers, the Association shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of the Association.

ARTICLE III

The duration of the Association shall be perpe-

tual.

ARTICLE 1V

The Association shall be a nonprofit corporation, without shares of stock.

ARTICLE V

The authorized number and qualifications of members of the Association, the different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability to does and assessments and the method of collection thereof, shall be as set forth in the Bylaws and Declaration.

ARTICLE VI

The initial registered office of the corporation thall be located at 3951 Apollo Drive / Alaska.
