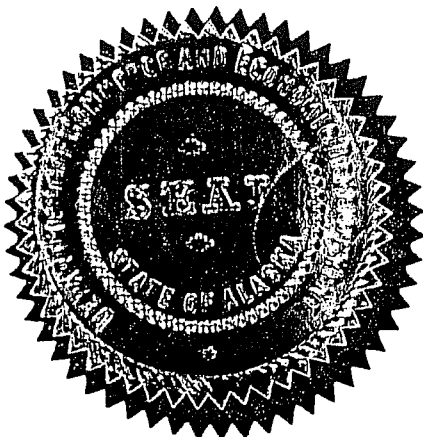

ARTICLES OF AMEDEMMENT OF NOBB HILL CONDOMINIUMS, INC. STATE OF ALASKA DEPARTMENT OF COMMERCE & ECONOMIC DEVELOPMENT

1. The name of the corporation is NOBB HILL CONDOMINIUMS, INC. to be changed to NOB HILL CONDOMINIUMS, INC. by leaving off the last "B" in NOBB.

2. The adopted amendment is to change the name of the nonprofit corporation from NOBB HILL CONDOMINIUMS, INC. to NOB HILL CONDOMINIUMS, INC.

3. Pursuant to A.S. 10.20.176(b) the amendment was adopted at a meeting of the Board of Directors.

4. The date of the meeting was July 15, 1983 at a Board of Directors meeting and a quorum was present at the meeting and the meeting received at least two-thirds of the votes of the members present in the office.
